Secretary Report: Hank reported that we have a balance of \$11,019.67 in the account as of Oct. 1, 2016. Hank will report to the Board in January as to our status and what we will have as a balance after bills are paid.

Apprentice: Terri Warren gave the following report: We have 14 interested apprentices with two paid as of today. Many are

umpiring other sports with the NHIAA so insurance registration is less of an issue. Terri will need 25 full set of books

for the apprentices. Three books –Rules, case and umpire manual. Classes are scheduled for every Sunday in

February 2017 from 10-2. The newspaper add is ready and will be sent to Hank to send to newspapers. The Federation

clips work again and will be used for instruction in classroom work and mechanic classics.

Evaluator: 45 evaluations were done in 2016. Jim will work with Billy to set up pairs of umpires that need to be evaluated in 2017.
